POLITICAL GUIDELINES

The XVth COCAL conference, to be held in Gatineau in August 2024, will focus on the many challenges facing contract academic staff as contingent academic labour, and the means we can use to mobilize and address them. These challenges, derived directly from the commodification of knowledge, threaten our working conditions, our representation in the University, our academic freedom, our potential in research and community service, and even our very profession. To reverse this trend, collective action remains our most formidable tool for bringing about the changes needed to support free, egalitarian and pluralistic education.

COCAL participants are invited to discuss and debate a range of issues affecting contract academic staff, including their working conditions, their place (and invisibility), and threats to the very mission of universities. We'll also discuss why and how to mobilize, and the importance of organizing a North American day of mobilization.
